- 1. Fire Safe Council responses to the Fire Service and BLM audits are underway.
- 2. Hiring

a. Firefighter/Paramedic Positions - a four agency consortium will be kicking off a hiring process on August 1 with a three week application period, then September 1 testing will begin and the hiring list should be completed by October 1. TDFPD has 3-4 openings.

b. Fire Inspector Position – Application period is closed with 25 applicants. Seven will be interviewed by a panel on August 1, the top 3 candidates will interview with the Fire Chief on August 2.

Financial Summary

A Step up Bond was called this month, August will have three pay periods so liquidity needs are being closely monitored.
